Current School Priorities

2. Leadership

2a SLT to apply closer scrutiny and analysis to accelerate progress of SEN in most year groups.

2b SENDCo to triangulate monitoring of Interventions (in and out of class), specific provision for SEN pupils on planning, quality of teaching and learning delivered by teachers and support staff and accuracy of evidence in terms of progress and attainment.

2c Develop the leadership and planning of key skills in science.

3. Teaching Learning and Assessment

- **3a** Carefully consider how staff support, scaffold and guide the lower ability groups so that their autonomy in learning increases while pupils still make rapid progress.
- **3b** Continue the progress and attainment of the disadvantaged and SEND groups by taking time to monitor and sample their learning within lessons and overtime. This will ensure that good use of the PPG funding is being made.
- **3c** Look further at the precise use of punctuation to add effect to writing compositions.
- **3d** Further enhance the physical learning environment in key stage 1 to ensure that displays are informative, helpful and capture and celebrate learning.
- **3e** Ensure that MA pupils are always challenged to achieve their best (Review capacity within WALTs)
- **3f** Teachers to capture responses to key questions in topic work in a more systematic way.
- **3g** Provide support and guidance for the newly appointed Year 5 teacher.

4. EYFS (Curriculum)

4a Further improve resources in the EYFS in order to achieve an even higher standard of early learning.

5. Outcomes

- **5a** Embed the improvements noted in key stage 1 and continue to check and moderate teaching, learning and assessment to ensure consistency, especially in Year 2.
- **5b** The SEND, disadvantaged and low prior attainment group need further consideration as the progress, attainment and outcomes in books show that they lack the independence skills required to be successful learners
- **5c** More able pupils in Year 2 need to make better progress in the core subjects for the academy to be in line or exceed the national average in 2018.
- **5d** Outcomes in the foundation subjects need further consideration, especially in science. Increase opportunities to learn the key scientific skills or knowledge that is required to be a successful scientist.

6.Personal Development and Welfare

- **6a** Consider how best to develop this area especially within the personal development: learning mentors and e-cadets might be a worthwhile idea and Troon Primary Academy run these initiatives to a high standard.
- **6b** Embed the use of MAT BLP systems to further develop learners' resilience and capacity for reflection.
